

Car Rental on Texel

Information 2025

- Also for rent: winter tires, snow chains, ski and roof boxes.

We have various means of transportation available for you. Reserve at your desired time to ensure the vehicle is available when you need it.

For a fun, environmentally friendly (holiday) day with our electric Opel Corsa-e or an afternoon of moving in one of our vans.

In this brochure, you will find our offer; the color or model may vary due to regular expansion of our fleet.

Reservation

You can reserve your rental car in the following ways:

- At the counter • By phone (tel. 0222-318000) • E-mail (info@garagerentenaar.nl)
- For cancellations less than 24 hours before the start of the rental period, a €25 cancellation fee will be charged.

Terms

- A deposit of € 200 is required per rental; this can also be pinned.
- The car must be returned with a full tank. If we have to refuel, we will charge an extra €10.
- Reservations can always be canceled.
- Payments can be made with cash or debit card. We do not accept credit cards.
- The car can be returned outside opening hours. However, the driver remains responsible for the car until intake.
- We can arrange delivery or pickup. Costs: from €10.
- Our cars can go with the ferry for Texel Rate. That's an advantage for you!
- The passenger cars have a parking voucher.
- The moving van, furniture van, and 9-seater van do NOT have a parking voucher.
- The hirer himself is responsible for carrying an environmental sticker in the country he/she is travelling through, this also applies to the environmental zones in the cities at home and abroad, any resulting Decisions (fines), including handling costs (amounting to €15.00), are at the expense of the hirer/driver.

Rental Period

- We rent cars/trailers per calendar day, not per 24 hours. Our calendar day starts at 08:00 and ends at 08:30 the next morning. After closing time, you can park the car, lock it, and deposit the key in the key safe. If the car/trailer is available the evening before the rental period, it may be picked up between 17:00 and 17:30 at no extra cost.
- Long Weekend rental starts on Friday afternoon after 17:00 and lasts until the following Monday at 8:30.
- The rental agreement remains in force, and the rental sum is due until the day the vehicle is actually received by the lessor, regardless of the lessor's further right to compensation and/or having the vehicle retrieved.

Insurance (adjusted conditions as of 01-01-2025)

The cars are insured. There is a deductible of €1,500.00 per claim, this also applies to damage to the other party. This amount can be reduced to €500.00, with a buy-off of €15.00 per rental day.

(Different conditions apply for the Furniture van. See our website for the conditions).

If you are 23 years or younger, or have had your driving license for less than 1 year, this cannot be bought off.

If you take the car abroad, you must inform us in advance. The extra insurance costs are €15.00.

Additional insurance and surcharges

You can contact us for additional insurances. The payments will be made according to the conditions available at our branch and in every vehicle.

Surcharges and Insurance

The liability insurance (WA) is only valid within the Netherlands unless foreign coverage has been taken out.

All vehicles are standard WA insured. The vehicles are insured with WA coverage up to €2,000,000 per occurrence. A deductible applies per claim for both WA and comprehensive damages, this also applies to damage to the other party.

In many cases, this deductible can be reduced by paying a buy-off amount per day/week.

Additional Terms (adjusted conditions as of 01-01-2025)

- The renter/driver must be at least 20 years old and have held his/her Dutch driving license and an EU passport/ID card for at least 2 years.
- In certain cases, the renter remains fully liable for the damage, regardless of the agreed deductible.
- Our vehicles may only be used within the Netherlands unless foreign coverage has been taken out.
- Damage to the transported goods and personal belongings is at your own risk.
- For courier, taxi, and/or transport companies, the deductible or the reduced deductible is increased to 400%.
- All prices exclude fuel. All cars are delivered with a full tank. The car must be returned with a full tank, otherwise, a refueling surcharge of €10.00 excl. VAT applies.
- Overhead damage (damage above the windows) and glass damage is always at the renter's expense.
- Dogs are not allowed in the rental car, if detected, a €25 cleaning fee will be charged.

Different conditions for furniture van (van with tail lift) (adjusted conditions as of 01-01-2025)

- The deductible is €1,500.00.
- Cost of buying off deductible €15.00 per day.
- Permanent deductible €500.00. The deductible applies to each claim, including damage to third parties and/or buildings. Overhead damage and damage to the furniture van itself are always at the renter's expense, regardless of the deductible, meaning it's at their own expense.

** We define overhead damage as damage above the window line.*

*** The definition for furniture van is the structure behind the cabin and everything attached to it.*

Service

All vehicles are in top condition. If you unexpectedly encounter breakdowns, we are available during opening hours. Our employees will help you get back on the road as soon as possible. Outside opening hours, the car is registered for breakdown assistance; this information is in the glove compartment.

In case of breakdown, you must first ask the lessor for permission regarding the costs. Otherwise, these costs are at your own expense.

Fines

Fines, including handling costs (ad. €15.00), are at the expense of the renter/driver.

Abroad

If you wish to travel abroad, you are obliged to take out foreign insurance. Traveling abroad with our rental cars is only allowed in Belgium, Denmark, Germany, Finland, France, Ireland, Italy, Liechtenstein, Luxembourg, Malta, Monaco, Norway, Austria, Portugal, San Marino, Spain, United Kingdom, Sweden, and Switzerland.

Identification and Deposit

Identification is mandatory, by means of a valid driver's license. Renters who are not residents of the Netherlands must bring a valid passport, a valid driver's license when picking up the rental car. If a non-Western script is on the driver's license, an international driver's license must also be presented along with the original. Photocopies of these documents are made which we archive. We reserve the right to refuse to rent a car without giving any reason in certain cases.
